In terms of background, as intimated previously, a pledge was created over an aggregate of 425,072,295 Units held by certain Blackstone Sponsor Group entities in favour of Deutsche Bank A.G, in its capacity as the security agent ("Agent"), in relation to a credit facility availed by NXST ML (NQ) Limited ("Borrower") from specific overseas banks as required under the terms of, the facility agreement dated June 13, 2024 (the "Facility Agreement").
